## ACE Aquatics visit:

Two incidents where toddlers have fallen into the pool. Need to understand proper protocol from life guards.

Individual guard has been spoken to regarding incident, as well as all guards have been given a reminder about if a parent goes in the pool after a child, the guard must also jump into the pool. There must also be adequate follow up from the guard to ensure the family is safe.

Protocol, if a guard jumps off a stand, another guard who sees this is to blow the whistle in order to clear the pool. Two short whistle blasts, signals that a guard is in need of help.

### Post Labor Day Hours:

3 week prior to Labor Day, we must alert ACE if we want to keep those two September weekends.

Discussion to keep pool open one additional weekend. Do not begin clean up until closing time, hire guards to assist with closing the facilities.

Motion to keep the pool open September 6, 7, 8. The motion passed unanimously. There is a 3 week time line needed to cancel this additional weekend or to ask if we want the second week of September is wanted.

As a side note it is recommended that no pool parties are booked at the club house while the pool is open on weekends, yet not during the week.
