
MINUTES OF THE BRPA BOARD - MAY 10, 2022

In accordance with the bylaws, a meeting of the BRPA Board of Directors was held on Tuesday, May 10, 2022 at the pool clubhouse.





A quorum being present, the meeting was called to order by Bill Thomas, acting for Jay Green and Cameron Arterton, at 7:35.

The Board approved the minutes of the April 12, 2022 board meeting.

Cameron Arterton joined the meeting and chaired the remainder of the meeting, acting for Jay Green.

Bill Thomas reviewed the financials which are on track with expectations. He provided an update on membership through May 10. We are still short of last year's total but expect to make it up as we approach pool opening. Cheryl has reminded swim team member families to join. Tina Andrews is sending a request to all Annapolis Cove families inviting them to join the pool.

It was noted that we should track use of the pool by charter members. Last year we had eighteen initiation fees come in; this year to date we have two. We will have a membership table at the opening weekend party.

It was reported that Evan Kelso (Annapolis Cove) will run the snack shack this year. Salley Wood has approved and will be the point of contact for BRPA for the snack shack this season.

Cheryl is checking MemberSplash every day to manage applicants through the joining process. She reports that it is working well.

PREPARATIONS FOR OPENING
