Dear C/O Jamie Gonsalves:

Enclosed is Deer Management Permit (DMP) #02111 for your property where crop damage has occurred. Possession of this permit requires you adhere to the following current Department of Natural Resources policies and regulations:

- Unless otherwise noted, your permit expires on February 28, 2026. A signed Master Copy of the
 Confirmation Number Log Sheet must be returned within 5 days after the permit is filled or no later than
 March 15, 2026. Failure to do so may result in citations from the Natural Resources Police and/or denial of future
 DMP's.
- 2. To renew your permit next year, fill out the information included on the Master Copy of the Confirmation Number Log Sheet included with this permit. If you need to make changes to your next permit you may note those changes on page 2 of that form. Send the Master Copy of the Confirmation Number Log Sheet, and if needed, the renewal form that includes the full legal names and DNRids for your shooters, to the DNR address or email address listed above at renewal time in 2026. DNRids must be included. Please note that the actual landowners will be required to also sign the permit renewal.
- 3. You may request <u>early permit renewal</u> starting on February 1 by sending in a signed photocopy of your upto-date Master Copy of the Confirmation Number Log Sheet with the appropriate information filled out. When the appropriate updated information is received by February 15, a new permit will be sent to you prior to March 1. This will allow you to continue to use the permit without a break. If you are requesting early renewal, keep the original Master Copy of the Confirmation Number Log up-to-date until February 28 and save it for your records.
- 4. Only antierless deer (does and button bucks) may be taken, unless otherwise stated on the permit.
- 5. All deer taken under your Deer Management Permit must be registered with the Department's automated check-in system by using the toll free check-in number 1-888-800-0121, or the Internet at http://gamecheck.dnr.state.md.us, or by using the iPhone and Android app available at http://dnr.maryland.gov/Pages/dnrapp.aspx. Deer must be registered and receive a confirmation number within 24 hours of the time of harvest or recovery.

FAILURE TO REPORT DEER TAKEN UNDER YOUR DMP IN ACCORDANCE WITH THESE REGULATIONS IS A NATURAL RESOURCES VIOLATION AND WILL RESULT IN THE ISSUANCE OF CITATIONS FROM THE NATURAL RESOURCES POLICE AND DENIAL OF FUTURE PERMITS (COMAR 08.03.04.02).

NOTE: All shooters will need a DNRid number issued from DNR to complete the check-in process. The DNRid number can be obtained free of charge from a retail hunting license agent or online at http://dnr.maryland.gov/service/getDNRidcard.asp. The Deer Management Permit # is NOT your DNRid #.

- 6. Note: Harvest tag requirements and how confirmation numbers can be maintained have been modified:
 -Unless a confirmation number is obtained at the place of kill, before moving the deer it must be tagged with a
 shooter-provided tag that indicates DMP number, name, DNRid, date of harvest, and county of harvest. If a
 confirmation number is obtained at the place of kill, and the deer remains in the shooter's possession until processed
 for consumption, then a field tag is not required. Deer that have been checked in, but do not remain in possession of
 the shooter (for instance when left with a butcher or given to family or a friend), must be tagged with a field tag that
 includes the shooter's name and deer confirmation number.
 - -The confirmation number, along with date, species, and sex, must be recorded on the shooter log sheet or kept electronically on a mobile smart device as proof the deer was reported through the DNR check-in system. These records must be available and furnished upon request. Additional log sheets may be photocopied if needed.
 - -The confirmation number and relevant information must also be provided to the permit holder to be recorded on the DMP Master Log Sheet that is to be returned to the issuing DNR office by March 15, 2026.
- 7. Any shooter that is required to possess a Maryland hunting license to legally hunt on the permittee's property is also required to possess a hunting license when shooting under the DMP during the legal deer hunting season. A hunting license is not required when shooting is conducted outside of the legal Maryland deer hunting season. Individuals that have been convicted of a violation of Natural Resources Article, Title 10, Annotated Code of Maryland, within a 2-year period before the date of the application for the deer management permit are not eligible to receive a DMP or serve as an agent.
 - Please also remember that anyone shooting deer under the authority of your DMP at any time during the year must meet the Maryland Hunter Education and Safety Requirement.
- 8. The authorized shooters on the permit may not be changed without notifying Wildlife and Heritage Service staff during regular business hours. Added shooters do not become effective on the permit until a background check has been completed and you have received a new copy of the permit showing the changes.
- 9. Please note that all permittees and agents (exempt and non-exempt) shooting deer under the authority of a valid Deer Management Permit may now shoot deer from March 1 through February 28 using any firearm, bow, crossbow, or muzzleloader legal for hunting deer in that county. Rifles may not be used in shotgun-only zones unless specified otherwise on the permit. Other conditions for using a DMP are described in detail on the permit and in the General Conditions document.
- 10. NOTE: Straight-walled cartridge rifles may be used as a substitute for shotguns. Please consult the 'Guide to Hunting and Trapping in Maryland' online (https://dnr.maryland.gov) or that comes with the regular state hunting license for further information on these firearms.

In closing, please remember that DMP's are designed to be used by landowners with severe crop damage in conjunction with a hunting program. The key to reducing deer damage is to reduce the deer population on your property by targeting adult does for harvest and increasing hunter participation on your property during the established deer hunting seasons.

This Permit is issued to harvest 30 antierless deer causing damage to crops under authority of Natural Resources Article, Title 10, Section 206. Permit is valid only on property identified above.

Special Conditions: Archery Only

Authorized Agents for Permit #: 02111

The proper representative from Wildlife and Heritage Service must be notified prior to making additions or deletions to the list of authorized agents (Exempt or Non-Exempt).

Exempt agents are defined as: permittees and designated agents who are exempt from the requirement to possess a hunting license for the property for which the Deer Management Permit has been issued (as defined in Maryland Law 10-301b); or designated agents who are employees of the permittee's commercial farming operation (i.e., recipients of federal W-2 forms); or nonresident landowners who possess a Maryland Hunting License. The following agents are exempt:

Agents that do not meet the requirements to be exempt are classified as non-exempt agents. Non-exempt agents must possess a Maryland hunting license when shooting under this DMP during the Maryland deer season. The following agents, listed with their shooter code number, are designated as non-exempt:

Shooting hours are 1/2 hour before sunrise to 1/2 hour after sunset as follows:

March 1 - February 28: Monday - Sunday

Permittees and all agents may use any device otherwise legal for hunting deer in Anne Arundel County. Permittees and agents are not permitted to use bottleneck cartridge rifles if the DMP property is within a designated shotgun zone unless specified otherwise on the permit. Straight-walled cartridge rifles are permitted in shotgun zones.

THIS PERMIT IS VALID FOR ANTLERLESS DEER ONLY UNLESS OTHERWISE SPECIFIED

Deer taken under this permit must be consumed or otherwise utilized by the permittee/agent or donated to other individuals or charitable organizations for the purpose of consumption.

Permittees and agents shooting deer under authority of a Deer Management Permit using firearms at anytime (including muzzleloaders), and permittees and agents using any hunting device during a firearm, muzzleloader, or primitive season, must wear a cap or vest of solid daylight fluorescent orange; or vest/jacket containing both front and back panels of at least 250 square inches each of solid daylight fluorescent orange; or an outer garment of camouflage fluorescent orange worn above the waist which contains at least 50 percent daylight fluorescent orange.

Reporting Instructions

Each deer taken under this permit must be reported within 24 hours of the time of harvest by calling 1-888-800-0121 or visiting the Internet site http://gamecheck.dnr.state.md.us or using the smartphone app available at http://dnr.maryland.gov/Pages/dnrapp.aspx. At the completion of the call or Internet visit a confirmation number will be issued that must be recorded on the included Master Confirmation Log Sheet by the permittee. The shooter must also either record the confirmation number on the enclosed Shooter Log Sheet or maintain it electronically on a mobile smart device to be furnished upon request. Unless a confirmation number is obtained at the place of kill, before moving the deer it must be tagged with a shooter-provided tag that indicates DMP number, name, DNRid, date of harvest, and county of harvest. If a confirmation number is obtained at the place of kill, and the deer remains in the shooter's possession until processed for consumption, then a field tag is not required. Deer that have been checked in but do not remain in possession of the shooter (for instance when left with a butcher or given to family or a friend), must be tagged with a field tag that includes the shooter's name and deer confirmation number. Within five days after the permit is filled or no later than March 15, 2026, whichever comes first, the Master Copy of the Confirmation Number Log Sheet complete with all deer taken and their confirmation numbers must be returned along with this permit to the mailing address or email address provided on page one of the permit. Failure to comply with these instructions may result in the issuance of citations from the Natural Resources Police and/or denial of future Deer Management Permits.

Permittee and all Agents: -Must meet the requirements to possess a Maryland hunting license and firearm

-Must have a copy of this permit signed by both the permittee and the agent in possession while conducting the shooting of deer

-Must not have been convicted of an Annotated Code of Maryland, Natural Resources Article 10 violation within two years prior to issuance of this permit.

My signature attests that I have read both pages of this Deer Management Permit and understand the terms, guidelines and conditions of this Permit.

I certify, under penalty of perjury, that I meet the Maryland Hunter Education and Safety Requirement and have provided correct representation of my personal information. (Permittees not shooting deer themselves under the authority of this DMP do not need to meet the Hunter Safety requirement).

This penalty applies for each deer killed over the authorized number, for disposing of deer in an unlawful manner, or for violating any of the special conditions of this permit. The permittee and all agents agree to the above conditions.




